Dear Chapel Family, February 2017

The Saratoga Hall Taskforce wishes to provide you with an update on our Saratoga Hall project, providing information both on the current milestone and on progress regarding other milestones to completion. We seek your continued prayers for God's direction and guidance in completing this space for His work.

#### **CURRENT MILESTONE STATUS**

There are **five milestones** remaining to complete this project according to our original 2006 plan:

1. Complete Saratoga Hall as defined by Island County Building and Health Departments: ...... \$153,397

Our Building permit expires in July 2017, which can be extended one additional year. To meet this deadline, all work must be completed by July 2018. Work Includes: remaining lighting controls, cabinets & counter tops, flooring, plumbing fixtures, fire escape, drop ceiling panels, doors, hardware, millwork, and landscaping. PRAISE: \$260,104 has been given toward Milestone #1 since November 1<sup>st</sup>, 2016. Our remaining need is \$153,397.

Dear fellow church members,

My daughter, Colleen Johnson, came home from helping put the bulletins together one day at the church and sprung on me a new revelation that never occurred to me before.

She asked me, "What do you really think about Saratoga Hall?" I replied, "I think of it as a new facility for the pastors and staff and an insurmountable amount of money that has to be raised, and my small contribution would hardly make a dent." She replied "I used to feel somewhat the same way."

Then Colleen said to me, "Do the math, Dad. Let's say there are approximately 850 attendees (possibly representing 400 individuals who give to Camano Chapel). If you take the \$153,400 required over the next five months to meet Island County permit requirements for Saratoga Hall, and divide it by the 400 individuals, that would be about \$383/person or \$19 a week." I thought, "WOW, that's easy, I can do that and more, to cover those that are not as fortunate as I am."

"That's well and good honey, but is it really needed?" "Dad, Camano Chapel does need the space for many ministries for those who are lost, those who need help and especially the younger generation who don't know the love of Christ. Look at Saratoga Hall as a 'tool of the Lord' where the love of the Lord is expressed in meals for some, a place of refuge and outreach, teaching God's Word and the exercising of many other spiritual gifts that will affect people in our community for the rest of their lives."

I started thinking of the difficult task the church leaders have to go through to raise money to fill the needs of the people that the Lord is sending to us. I felt ashamed for my indifferent attitude. The reality is, this should not be the responsibility of the church leaders, but us, the congregation, leaving the pastors and staff free to minister to those the Lord has sent to us.

If you find any of the thoughts expressed above reflects some of your own thinking, let us free the leaders of this task and worry of raising money to meet the July deadline when the building permits expire for Saratoga Hall. We can take on this responsibility by putting either a weekly offering or one time offering for Saratoga Hall. Let's fill the offering tray with Saratoga Hall envelopes.
